# Symposium Evaluation


## Attendance

## Evaluation


- 56 people completed evaluations
- 63 percent said the symposium was very valuable:
  - Very valuable 63%
  - Somewhat valuable 29%
  - Neutral 7%
  - Minimal value 2%
  - Not valuable at all 0%
- 77 percent said that Supervisor Kuehl's presentation was very valuable
- 64 percent said that the organization of the symposium was excellent
- 61 percent said that the relevance of the symposium was excellent

## 56 Participants Completed Evaluations of the Symposium




## Please indicate how valuable you found each aspect of the symposium

What would you be interested in hearing about and discussing at future Economic Roundtable symposia?




#### Homelessness

#### Time
